- 4. The approval for empanelment will continue to hold only if the manufacturer has installed atleast 500 sq.m. of collector area during the period of one year. The validity of approval may also be reviewed for withdrawal by the Ministry in the following cases:
- (a). When the quarterly performance reports, as mentioned above, are not submitted.
- (b). When inspection report of the Committee constituted by the Ministry for the purpose of verification of the information provided by the manufacturer brings out deviations; the Committee consisting of the representatives of Test Centres, Manufacturers Associations, user organizations and MNRE may visit installations or the premises of the manufacturer.
- 5. This is being issued with the approval of Joint Secretary (JNNSM). The consolidated list is being posted on MNRE website.
